IAPS Terms and Conditions

- To be included in each IAPS activity with registrations -

- 1. IAPS will handle all personal data confidentially in accordance with GDPR and IAPS regulations. You agree to IAPS processing your personal identifiable information according to the IAPS Privacy Notice, which can be found on the IAPS website. Furthermore, your data will not be forwarded to any third parties except where necessary for the purpose of the IAPS activity, this includes information provided from your registration form to other involved parties when required. Where possible, IAPS will sign a data sharing agreement with said third parties beforehand and will always act in accordance with GDPR. IAPS may disclose personally identifiable information to its member committees in order to ascertain a valid membership subscription to the said committee to confirm your attendance of an IAPS event. IAPS may send you event specific information for the IAPS event you have registered for, but never marketing emails about other IAPS events without your expressed consent.
- 2. Only individuals who are members of IAPS, any of its member committees or those who have completed their university studies no more than 12 months prior may take part in IAPS major events. IAPS membership may be required for other IAPS events, as agreed by the Organising Committee and the IAPS Executive Committee. Only students with an age of at least 18 years are allowed to attend IAPS events.
- 3. You acknowledge and agree that IAPS, the organising committee and the hosts of the event have no responsibility whatsoever for any personal injuries, death, losses, or damages incurred as a result from your participation in the event, except in the case where such personal injury or death is due to the negligence of IAPS, the organising committee and the hosts of the event.
- 4. By participating in the event, you agree to be filmed, photographed, and otherwise recorded for the duration of the event and hereby expressly grant the organising committee and IAPS the right to use and store your picture, movie or any other form of media publication. You can opt out of this at any point by informing IAPS or the Organising Committee.
- 5. You also confirm that the information contained in this application is true and correct.
- 6. You accept that the organising committee and IAPS cannot be made responsible for the content of any talk, poster, workshop, excursion or similar activity.

- 7. You accept that, in case of cancellation by a participant, the Organising Committee will provide a reimbursement only if it is in accordance with the reimbursement procedure of that event. No reimbursement will be given for membership fees under any circumstances. If a reimbursement were to be approved, the Organising Committee will may retain a total of 10€ from the fee as a contribution of the expenses of the event. All decisions about financial aspects of the event will need to be approved by the entire Organising Committee and are not open to appeal.
- 8. The present terms and conditions are governed by the laws of the country in which the event takes place. Furthermore, you agree to abide by the law of the host country.
